5. Owner warrants and represents that it has the full legal right and power to make and perform this License and to grant all of the rights granted herein without limitation or restriction. Owner agrees to defend, indemnify, and hold Licensee and MTV Networks harmless from any and all costs and expenses (including, but not limited to, reasonable attorneys fees), losses, claims, liabilities or obligations arising out of any breach by Owner of the representations and warranties made by Owner herein.
